It is notified for general information of the public and staff that sealed quotation for under mentioned rights are invited on **30.03.2010** at **10.00 hrs to 13.00 hrs.** for the period of 1 year in the office of the DRM(W)/KIR and will be opened on the same date **15.30 hrs.** by **DEN/IV/KIR.** DA-I/KIR. Quotation received beyond time limit will not be entertained.

All interested persons are requested to participate in the auction. Questioners will be required to deposit 50% amount of the Reserve price plus earnest money 10% of R/Price against the quotation in the shape of demand draft well in advance in favour of FA & CAO, N.F. Railway/MLG. Payable at Katihar along with quotation papers addressed to **DRM(W)/KIR , N.F.Rly Katihar** with their clear signature and address. One man can drop only one sealed quotation. Any additional quotation dropped by same persons against same rights and quotation without above mentioned amount will summarily be rejected.

Successful questioner will be required to deposit accepted quotation value and sales tax @ 8% of quotation value for West Bengal portion and 12% of quotation value plus 1% addl.Tax ( multi point) for Bihar portion through Demand Draft in favour of FA & CAO, N.F.Railway, Maligaon at payable at Katihar along with security deposit money 20% of accepted value for the entire period of the rights within 7 (Seven) days time from the date of receipt of the acceptance letter positively in shape of bank instrument issued by any Nationalized Bank as FD/STDR/DD which should be authenticated from the concerned issuing bank and duly signed by the depositor on the reverse side affixing revenue stamp. The above bank instruments must be drawn in favour of FA & CAO, N.F.Railway, Malligaon payable at Katihar.
